From 2026, when activities will begin at full speed, a stable flow of visits to Santo Stefano coming exclusively from Ventotene with authorised boats is expected.

The number of visitors is limited to a maximum of 280 per day and the visiting period is set at 8 months per year, respecting the fragile environmental balance, the protection constraints and the marine weather conditions.

The project

The project was launched in 2016 by the then Prime Minister Renzi with Minister Franceschini, in the presence of Chancellor Merkel and President Hollande.

In 2017, the "Institutional Development Contract" was signed, which provides for the "reuse of the entire complex for primarily cultural and higher education purposes". In January 2020, with the Presidential Decree appointing the Extraordinary Commissioner, the project was set in motion once again.

Vision and purposes

- Restore to collective memory the historical events and human experiences that have marked the 170 years of the Prison's life, highlighting topics such as the dignity of the person, human rights and freedom of thought, as well as the evolution of architecture, prison culture and the concept of punishment.
- Promote a "School of Higher Thoughts" (Eugenio Perucatti, former "enlightened" Director of the Prison) inspired by the values of the Italian and European Constitutions, for the future of Europe and the Mediterranean.
- Protecting and enhancing the cultural, natural landscape and environmental heritage in line with the European Green Deal.
- Promoting cultural and artistic production.



The rebirth

1987: the former prison is declared an asset of major historical interest

1997-99: the Marine Protected Area and the Ventotene and Santo Stefano Islands State Nature Reserve are established

2008: the island of Santo Stefano is declared a National Monument

2016: the Government allocated 70 million euro for the restoration and recovery of the former prison

2017: signing of the Permanent Institutional Contract (CIS) by eight Administrations (state, regional, local) represented at the Permanent Institutional Table (TIP) and with Invitalia as the implementing entity

A new beginning

January 2020: Silvia Costa is appointed Government Commissioner

June 2020: signing of the MIBACT/INVITALIA agreement to launch operations

June 2020: approval of the 2020-2023 Operational Plan and Timetable by TIP

November 2020: the project of "urgent measures for securing the complex" begins (ending in March 2021)

February 2021: the Ventotene Town Council approves the project master plan drawn up with experts



March 2021: publication of the call for tenders for the project of "urgent measures for securing the complex" (set to begin in October 2021)

April 2021: set up and opening at the Ventotene port of the Infopoint showing the implementation stages of the project

May 2021: approval of the Feasibility Study by the Permanent Institutional Table

June 2021: approval of the Document Design Guidelines and the new Economic Framework of the Project by the Permanent Institutional Board. The expenditure of 70 million euros for the implementation of all the CIS interventions is confirmed

June 2021: publication of the Invitalia call for tenders for the international design competition for the entire former prison complex. Deadline for submission of projects: 23rd September 2021
